# Mark Boyd's notes from call with AACS legal counsel, Steve Cummings

Dan:

I spoke with Steve who said he has spent about 30hrs reviewing the PPP this week. He said <u>the bottom line is that AACS believes that our religious freedom</u> and exemption will be protected. He referred me to page 27 of a 31 page SBA Interim Final Rule that states all loans guaranteed by the SBA pursuant to the CARES Act will be made consistent with constitutional, statutory, and regulatory protections for religious liberty, including the First Amendment to the Constitution, the Religious Freedom Restoration Act, etc. See the attachment bottom of page 27 and especially the top of page 28.
